Dear Chanute Restoration Advisory Board Member or member of the public:

A Public Meeting for the former Chanute AFB will be held on 16 May 2012 from noon to 1 p.m. The Public Meeting is being held to allow the public to provide input on a Proposed Plan for two sites collectively called Group 2. The plan proposes No Further Action for one site and remedial alternatives for impacted groundwater at the other site. The 30-day public comment period for the Proposed Plan will end on 15 June 2012 at 5 p.m. The Proposed Plan and Summary Sheet may be viewed at the Information Repository at the Rantoul Public Library, 2106 W. Flessner Avenue. Copies of the Proposed Plan and Summary Sheet will also be provided at the Public Meeting. A Question and Answer Session will be held later the same day starting at 7 p.m. The Question and Answer Session is being held for any interested parties that have questions about the Proposed Plan and the environmental cleanup at the former Chanute AFB and its progress.

A Restoration Advisory Board (RAB) Meeting will be held on 17 May 2012 from noon to 1 p.m. The RAB Meeting serves as the quarterly update for environmental progress and property transfer. The proposed agenda for the RAB Meeting is attached, along with the transcript from the 16 February 2012 Chanute RAB Meeting.

Note that all three meetings will be held at the Rantoul Business Center Conference Room, 601 South Century Boulevard, Rantoul, Illinois 61866.
