## The Kelly Story

For more than 80 years, Kelly Air Force Base was a symbol of air combat support and economic stability in San Antonio.

In 1995, the Base Realignment and Closure Commission recommended the Air Force consolidate workloads to other military depots or to private non-military organizations. As a result, Kelly officially closed its doors as an active military base July 13, 2001.

The former Kelly AFB managed more than 75 percent of the aircraft and auxiliary engines in the Air Force. During its active years, Kelly followed the laws and regulations in place for disposing of and handling fuels and other chemicals. Science now shows some chemicals were released into the shallow groundwater under the former base.

The Air Force is committed to cleaning up the contamination related to past maintenance practices at the former Kelly Air Force Base. The Air Force uses a number of innovative techniques to treat contamination of the shallow groundwater zone.

Today the former Kelly AFB is operating under a new name, Port Authority of San Antonio, with a new mission. As a multifunctional logistics port, Port Authority of San Antonio is again becoming an economic resource moving South Texas forward.
