                              Hi. My name is Doug Caras.
12
   I'm the Public Affairs Officer for Air Force Real
13
   Property Agency.
14
                   What I want to do briefly is just talk to
15
   you all about some of our sampling results that we got
16
   this year finalized in January. We sample the ground
17
   water every year and that's how we can tell if our
18
   systems are working properly and if we're making
19
   progress, and also just a general overview of a lot of
20
   other sites that we're dealing with here.
21
                   First, I'll talk a little bit about the
22
   chemicals of concern, the shallow ground water, what it
23
   is, sort of the plume data and our statistics in terms
24
   of size that we closed and sites that are still open.
25
                   Our main chemicals are concern of PCE,
```

```
Perchloroethylene, and TCE, Trichloroethylene. These on
 1
 2
    base were used as solvents to degrease engine parts from
 3
    aircraft.
               Through spills and the actual approved
 4
    disposal practices at the time, those chemicals entered
 5
    the ground water and we have a plume that extends from
 6
    east Kelly several miles east of the base.
 7
                   Along with TCE and PCE, which were the
 8
   chemicals we used on base, they break down into two
 9
   other chemicals before they become harmless substances.
10
    Those two other chemicals are Dichlorethylene and vinyl
11
   chloride.
12
                   (Man speaking in background - Inaudible.)

                              The shallow ground water is
                   MR. CARAS:
14
   15 to 40 feet beneath the surface. It's not a pool of
15
   water. It's more or less water trickling through the
16
   space between rock and dirt in the shallow ground
17
   water.
           So over the years, we dug about 1400 sampling
18
   wells.
            I think every year we still sample about 400 of
19
   them so that we can see what the extent of the plume is.
20
                   Fortunately us, it's not a drinking water
21
   source here and the Edwards aguifer is separated from
22
   this shallow ground water by a thousand feet of rock and
23
   clay.
24
                  Even if Kelly hadn't been here, we really
25
   wouldn't want to use this shallow ground water as a
```

1 drinking water source because you have a lot of other 2 things impacting that; you know, street run off, septic 3 tanks, fertilizers, gas stations, that sort of thing, 4 anywhere where you have underground storage tanks. 5 Right here, you can see, this is the PCE 6 contamination plume in the year of 1999. That was right 7 around the time where we felt very confident that we had 8 the whole plume characterized, that we knew the extent 9 and the concentration of the plume. 10 Can you go back one for me? 11 Right in this area, I'd like you to pay 12 special attention, because this way you can see how the 13 plume has changed in its shape and size over the last 14 five years. 15 Okay, next slide. 16 You can see now because of the source 17 control systems that we put in along these boundaries, 18 we've seen a great deal of change in the plume. 19 separated into two different lobes and so we've seen a 20 great deal of reduction in the plume. 21 Now one thing I want to talk about, since 22 I'm up here, is that we're putting in off base systems. 23 One we've just finished putting in last 24 month at 34th Street. It's a permeable reactive

What that is is you more or less dig a

25

barrier.

1 trench. You fill it with sand and iron filings. As the 2 ground water brings the contamination into contact with 3 iron filings, the chemical solvents are broken down into 4 harmless substances. As I said, we just finished 5 putting one in there. Later on this year, we'll put one 6 in this area and one along in this area near Commerce 7 Street. 8 Now what that does is we have sealed off 9 the sources of contamination and now we're going out to 10 put systems in to treat the areas of highest 11 concentration off base. 12 Next slide. 13 Okay. Now this is the TCE contamination 14 plume in 1999. This is of real importance here. 15 can see that we had TCE going off base at that time. 16 Go ahead next slide. 17 Now you can see that we don't really see that plume any more going off base. One of the things 18 19 that we did was we put one of those permeable reactive 20 barriers in there in 2002 so we have seen some, it looks 21 like we have seen some reduction as part of the 22 installation of that PRB. 23 Also along this area, we've seen a lot of 24 reduction in the plume as well. It used to be just a 25 solid sort of depiction of green along that area, so

we're seeing these systems work and we're really hopeful that once we get the other systems off base, we'll see some dramatic improvement as well.

Okay, I want to go ahead and just talk to the DCE, the breakdown products. This is what it looked like in 1999, 2003. This is what it looks like. We're not really seeing very much there, just some right in that area, or very little off base.

The next one, vinyl chloride, this is what it looked like in 1999. This is what it looks like today. Again, very little off base contamination from vinyl chloride.

This is more or less all of the sites we're working on. Our total is 708 sites. They're broken down into various categories determining as opposed to what the contamination is.

As of now, we've got -- next slide -we've have got about 40 percent of the sites closed. We
expect by 2010 we should have about 93 percent of the
sites closed. The remaining seven percent are part of
this installation restoration program. These are the
ones, for example, with the ground water where we have
to do long-term monitoring so we won't be able to close
those out for awhile, but hopefully by 2010, we'll have
about -- that's our plan is to have about 93 percent

    won't be able to officially close out with the

 9
    and if they do what we expect them to do, so every year
10
    we're going to be testing again and again to make sure
11
   that the systems are working properly and successfully.

   in place. You know, we can put the clean-up system in,
16
   but until it's completely done its work, we can't really
17
   close it out, you know, so we're going to have to do
18
   long-term monitoring. Like, for example, like some of
19
   the sites, perhaps if we have an underground storage
20
   tank, we can go in. We dig it up and we can dispose of
21
   it properly. We give the state a report or the
22
   regulators, the EPA and the state regulators a report,
23
   and then if they're satisfied with that, then we can
24
   close that site out, but some that require long-term
25
   monitoring we'll have to monitor for quite some time

    before we can show that everything is working properly.

You're talking 3 about the RAB charter, that it needs revision. 4 the RAB charter needs revision in view of the RAB rule, 5 but you should wait until that RAB rule becomes 6 effective so that you'll know how to change it, not just 7 jump into it and change it and have to change it again. 8 I think that needs to be done. 9 One other thing that needs to be done is 10 the TRS committee. Your TRS committee is the back bone 11 of this organization. It meets once a month. It has 12 not met at all this year, according to the little magnet 13 schedule that was handed out. 14 If the TRS committee had been meeting, 15 you would not have been surprised by what George just 16 mentioned, that the PRB's are not working, and that's 17 supposed to be the job of the technical review 18 sub-committee. 19 It's also the job of that technical review sub-committee to make sure that there are funds 20 21 to get a second opinion on some of the clean-up issues 22 that are brought before the RAB. That hasn't been done 23 in, oh, I'd say in the last four or five months. 24 The other thing that I wanted to talk 25 about is the community involvement plan. We worked for

1 a long period of time, since the year 2000, and it just 2 came out last week the community involvement plan. 3 That community involvement plan says that 4 the people, the community, do not have any trust in the 5 RAB or in the proceedings of the Air Force, nor is the 6 Air Force accountable to the community. None of you 7 voted for the PRB, none of the RAB members voted. 8 was shoved down the people's throat. This should not 9 happen. This is not community participation. 10 This is supposed to come from the 11 community. And that's just one of the many things 12 concerning the community involvement plan and concerning 13 account ability. 14 I've just learned from some of the people 15 that filed a \$10,000 lawsuit, I think there's 2000 of 16 them, and the Justice Department says, you know, we 17 would like to pay the \$10,000 to the people who have 18 filed this lawsuit for the damages that have occurred to 19 our property. 20 The people are saying that we've paid 21 taxes on properties, or not properties that have been 22 contaminated for years by the Air Force. The 34th Street permeable reactive barrier 24 was in progress and is currently completed. They just 25 have to finish doing the street repairs, and also the

I've asked for EPA and other pollution 21 records from the Air Force and all of this. I want to 22 know how this pollution can cause health problems for 23 the west siders, the south siders and east siders and 24 the southeast siders and the southwest siders and all of 25 this and I'm hitting a brick wall.

1 Now Mr. Antoine, I ask you this one time 2 that I need to see some action, I need to see some 3 reports, I need to see a plan of action, how we're going 4 to deal with the air pollution studies because I'm 5 losing my patience. I've brought this up time and time 6 again. I've looked into January meetings. Mrs. Galvan 7 and I brought that up back then and I'm not going to be 8 stonewalled any more. I want to see a plan of action. 9 I want to see something done as to how we're going to 10 deal with air pollution caused by Kelly and I want to 11 see a history of it and I want to see Air Force records, 12 EPA records and anything else you can dig up on all of 13 this thing, because we're not going to be treated as 14 second class citizens any more and have the monitors at 15 Marshall and at the airport and then on the east side 16 for the coal fired plants. 17 That wind from the coal fired plants also 18

That wind from the coal fired plants also blows this way into the southeast, the south side, the west side, the southwest and everywhere else. I'm not going to mess around with this any more. I need some questions, I need to put this on the agenda and it's about time this thing was studied, was begun studied in 1996 by the Alamo Area Council of Governments. It has been studied it ever since. They have several different types of clean air plans in place. There's some reports

on our compliance with the air standards and what's
going to happen with those air standards, and so far we
have not heard anything from the Air Force, the EPA or
anybody else. I'm sick and tired for waiting for all of
this. Now either I get this project going with one way

Also I need a status report on all health studies that are being done, not only by the health department but also from the ATSDR, and also we mentioned the agent orange. I would like to see some sheets on the health data sheets, Material Data Sheets on these chemicals and the Material Data Sheets that have been authorized by the hazardous communication laws, both state and federal, and what these chemicals have caused as part of the report and part of the presentation by the EPA people. And I would like to see a lot of that come our way pretty soon because we have not dealt with air pollution and a lot of this and I'm not going to get stonewalled any more.

One way or another, we're going to have to bring a lot of issues from the table and I want to see more health studies and I want to see a lot of the people that came in here complaining about health studies, I want them to be informed that they can go to

it's not just Kelly Air Force Base, it's the entire city and the entire county that I think we're starting to hear concerns about.

The issue of air monitoring stations throughout the City of San Antonio and why there aren't city or EPA or state air monitoring stations on Kelly Air Force Base is a valid question but it's something that we, as the Air Force, can't answer for the city or for the state, for that matter, or the county, so I think those are issues that we can look at.

The issue of historical air emissions, there's still an ATSDR report that we're also eagerly awaiting on past air emissions from Kelly Air Force Base, and I think we've relayed the concerns of trying to re-create data from the 1960's in the Vietnam era, when B52's were claimed to be flying in and out of here every three minutes.

What kind of emissions and what levels of emissions available to us today to re-create those scenarios, so those are some of the things that ATSDR is trying to piece together, through interviews of people who worked here at the time, estimating, you know, what kinds of air emissions these aircraft back in those days emitted.

1 They're doing models to try to project 2 the types of contaminants and the potential exposures, 3 but to try to re-create that information, I'm afraid 4 there was no data collected. There were not monitoring 5 systems available in the 1960's to do the kind of 6 analysis that I think a lot of people think is really 7 available to the Air Force. So that's unfortunate. 8 You know, medical technology is not to 9 the point, nor was data collection or legal requirements 10 So I'm afraid we're asking for a back during that time. 11 lot of things here as a RAB that we, it's humanly 12 impossible to re-create and to present, so, you know, I 13 have the same emotions that many of the people have 14 I have family and friends who have worked here 15 and died here at Kelly Air Force Base, so I appreciate 16 what you bring to us and we would surely like to address 17 all your concerns but I'm afraid that as a group, 18 sometimes we're asking for things that are just 19 impossible for us to deliver, and I'll apologize as many 20 times as I need to to this community and to you 21 individually for our inability to do that. 22 And so I hope you accept that and 23 hopefully you can accept what we're doing in terms of 24 progress in cleaning up the shallow ground water, as 25 Mr. Caras alluded to earlier, on 36th Street.

going on here, so you can see how it effects the people, people living there, people who have passed on and people who will continue to work there, so just take that and keep that in mind.
