Happy New Year to everyone. I take it 12 that everyone had a safe and happy beginning of 2004, 13 and this is the first meeting of the Kelly RAB or the 14 Kelly Restoration Advisory Board for 2004, and as we 15 have in the past, we've had this meeting to hold 16 elections for new members and also for members that are 17 being reconsidered for re-election. So with that, I'll 18 turn it over to David. 19 UNIDENTIFIED MALE: Thank you, sir. 20 goals for this meeting are to appoint new members to the 21 RAB in order to create a group that reflects diversified 22 interests of the community, to advise and comment on 23 former Kelly Air Force Base environmental matters and 24 documents and to receive updates on environmental

remediation projects.

1 Those goals will be reflected from the 2 agenda items as we work through this particular agenda. 3 RAB members, in your red packet, you will 4 find on the right side, for those of you who are 5 community members who are voting, you'll find a copy of RAB applications and a sample ballot that we'll be using 7 this evening. All of you will find a copy of a letter 8 from Dr. Gene Lenay, who, in fact, gives notice of his 9 resignation from the advisory Board effective on the 10 date of the letter, which was January 8, 2004, which 11 would create for us the responsibility to fill one more 12 RAB position tonight for a one year term, and we'll do 13 that as we complete some of the other process. 14 The left-hand side, of course, are the 15 minutes which you've already approved and an action item 16 response, which is the AFRP response to draft Technical 17 Review Report for the Zone 3 recla facility investigation. 18 19 That was an item that was requested and 20 will be discussed a little bit later this evening. 21 those are the items that are, in fact, in your packet, 22 and as I say, we will be reflecting those as we go 23 through the agenda this evening. 24 The next item on the agenda, in fact, is 25 our community comment time. We ask those of you who

1 wish to make a comment to provide us with a card and 2 we'll give you up to three minutes to respond to that. 3 Do we have any community comment cards 4 that we're aware of? I guess we're not going to have 5 those tonight. All right. 6 Let me take a minute and talk with you 7 then about the RAB community member appointment process. 8 Tonight, it takes the form of a three 9 phase process. It will become a little more confusing 10 than we really want it to be but in the effort to 11 reflect the interests of the community, it's been laid 12 out this way. The first time through, what we'll do is 13 you'll receive a ballot, RAB members, that will list 14 persons who are applying for membership, who, in fact, 1.5 live within the affected community, and from that 16 ballot, we'll be electing two people. We have two slots 17 available in that particular category. 18 Anyone who is on that ballot who is not 19 elected then is automatically moved to the next ballot, 20 which is for all of those persons who may or may not 21 live in the community, and on that ballot, we will be 22 electing seven people. 23 You will recall that in order to be 24 elected, you have to get four votes. You have to have 25 one more than half and tonight that will require four

1 | votes.

In that process, we may have to go
through multiple ballots, since we only have six voters
this evening, in order to get seven people with four
votes, so we'll give that our best shot and try to work
through it. As we've done in the past, we'll double
count ballots. We'll list outcomes of each balloting on
the Board so you can see how those things stand and
we'll try to work through as smoothly as we can.

The final phase in that process involves, as I suggested, the appointment of one party to replace Dr. Lenay for the one remaining year of his term. That person will be elected from among those who remain unelected on the other ballots, so we'll go through those three steps and then close off that process.

For your understanding, we have collected applications from those persons who would like to run for election, for appointment. You have those in your folder and I know you've had a chance to take a look at those.

We also have tried to notify those folks who we were going to call upon them, if they chose to do so, to speak for up to three minutes on themself and why they would choose to be a RAB member and what might qualify them for doing that.

1 We'll invite people to do that. Wе 2 should tell you that the executive committee worked 3 pretty hard on putting together a process, a ballot and a presentation process that was equitable. The way that 4 5 process worked was all party's names were placed in a 6 They were drawn for order on the ballot and order 7 on the ballot also paired up then with order of 8 presentation, so as you look at ballots, please know 9 that those are randomly selected, as will the 10 opportunity to present be randomly selected. 11 Community members, are you okay with that 12 process? Does it make sense to you to what we're 13 talking about so far? 14 Robin is here somewhere. Robin Thompson 15 will help us with the time process here so that we can, 16 in fact, give you your full three minutes, but she'll 17 probably get kind of testy if we run over the three 18 minutes so we'll try to notify of you that. She'll be 19 holding up cards that talk about three minutes, two 20 minutes, one minute, so you have some sense as to where 21 you stand in that process. 22 Having said all that, let us move into 23 our process. The first balloting will be for members 24 from the affected community.

If an 14 applicant is unable to attend the election meeting, he 15 or she may be considered if he or she informs one of the 16 co-chairs that he or she cannot attend." 17 "RAB members whose terms are ending must 18 notify the RAB of their intention to seek re-appointment 19 prior to the roll call voting for an appointment. 20 members are not required to complete a new application 2.1 since their original application has been filed 22 previously." 23 The only person that contacted me via a 24 telephone call that could not be here today is Ms. 25 She's on TDY and she would not be here Converse.

As we move 3 into the next part of the meeting, this is, in fact, the 4 presentation part of the meeting that addresses the 5 meeting goals about advising Kelly Air Force environmental matters and documents and receiving 6 7 updates on environmental remediation projects. 8 The next item on the agenda is item 9 number nine, which falls in that receiving update on 10 environmental remediation projects. 11 We're going to talk about the 34th Street 12 PRB update. Mr. Glass, from AFRPA is here to do that 13 presentation. John. 14 MR. GLASS: Good evening. I would like 15 to welcome everyone to the RAB and welcome the new 16 members that were just voted in. My name is John 17 Glass. I'm a project manager for the Air Force Real 18 Property Agency and one of the projects that I work on is a PRB that's located just north of Kelly Air Force 19 20 Base, or will be as soon as we get it installed. 21 I previously briefed the TRS sub-committee on the PRB with a detailed briefing, and 22 23 basically tonight my objective is to provide an update 24 to that previous briefing. 25

The PRB is designed to create a

1 contaminant plume of PEC that's originating from just 2 north of Kelly Air Force Base and may have co-mingled 3 with contaminants coming from Kelly Air Force Base and 4 basically the PRB will separate those two plumes prior 5 to where they may have co-mingled. 6 I have one drawing here this evening. 7 Kelly Air Force Base is right here at the bottom and 8 that's Grodan Road, which is just south of the North 9 Kelly Gardens community. 10 This street right here is 34th Street, 11 with this being North Kelly Gardens houses right over on this side, to the east. 12 13 We went in in early 2003 and installed a 14 bunch of sewer borings from basically the intersection 15 to about 900 foot north of the intersection and 16 determined that there was an area of increased 17 concentration of solvents that we needed to address 18 that's about 540 foot long and we contacted, through a 19 relatively new contracting mechanism, to have the PRB 20 constructed there and that had a certain level of effort 21 associated with it. 22 During some of the investigation works 23 and installing monitoring wells to monitor the PRB once 24 it's installed, they discovered an abandoned pipe water

That water main was outside the scope of

25

main there.

the current contract and we had to go back and clarify some contracting issues as to whether it was in or out of scope and then also seek funding to cover the additional cost of that pipe, and right now, that's where we're at. We're trying to get the funding in place to address the additional pipe.

If we can stick to the revised schedule, we should be in the field sometime in March and they will basically come in and start removing the pipes that are in the way and backfill behind that and the large excavators that are going to trench in the PRB will come in behind the initial crew removing the pipes and begin installing the PRB.

So other than the delay to get all the contracting issues resolved, the actual work in the field will overlap with most of the prior field work that had to occur and will cause very little extension in the field mobilization.

During that field mobilization, 34th

Street from Grodan Road to an area right up in this

area, where I'm pointing, which is about six or seven

hundred foot from the Grodan Road, will be closed off to

threw traffic while we have this PRB being installed.

The PRB will be approximately 30 inches wide and to adapt to around 35 foot. That may vary.

1 There may be places where they actually go to around 37 2 foot in depth. The PRB will consist of a sand and iron 3 mixture to get the designed amount of iron into that 4 trench. Portions of the trench need a one foot 5 equivalent of iron through its thickness spread across 6 of 30 inches, other portions only need one foot of iron, so you got foot and a half in one area and another area with a foot or higher, and that's spread across 30 inches, with the Delta made up with sand that gives them 10 the surface area that they need to make the chemical reactions recur to reduce the chlorinated solvents into 11 12 non-toxic constituent. 13 And basically that's what I have for you 14 tonight. Unless anyone has questions, if we can keep 15 this change on track, we'll be in the field in March. 16 UNIDENTIFIED MALE: Mr. Glass, if I may, 17 on 34th Street, what is the anticipated time of the 18 actual closing of the street during the day or evening 19 and what are the designated routes or detours that 2.0 individuals would have to take? 21 MR. GLASS: The road closure will be from 22 the beginning of construction through the end of 23 construction. It won't be opened and then later closed 24 back during that trench construction, it will be a 25 continuous closure.

1 The 34th Street ties into Grodan Road on 2 this end and near the northern end of it, off of this 3 map, there's a cross street, paved, curved, between it 4 and 34th Street, so people that live along 34th Street, 5 which is the path that most of them appear to take now, 6 is that side street over onto 35th Street and then out. 7 This area where we will be installing the PRB is basically a local dumping ground. 8 The city comes in, they remove the garbage. The weekend comes around, 10 the garbage is back. And looking at the wear and tear 11 on the road, most of the local residents aren't driving 12 through that area, probably because they would get 13 flats, I'm sure, and most of the wear and tear on the 14 street appears to be around that other cross street and 15 most of the houses are at that far northern end. 16 There's just a few down near where the PRB is being 17 installed. 18 There's a new house that was just 19 recently built and it's about a hundred foot from the 20 northern end of the PRB to that house that was recently 21 built. 22 UNIDENTIFIED MALE: Okav. So again 23 though, the question I had was, part of the question was 24 during the day, are you talking about hours of 25 construction of 8 a.m. to 4 p.m. or are they starting

We've asked the Air Force to place this PRB in here to cut off what may be coming from a upgraded source but it also again is co-mingling with Air Force contaminations coming off of Kelly, so it's going to be remediating anything downstream from where this reactive barrier is going in.

In the meantime, we'll be working through

1 The purpose of this plume, the purpose of 2 this remediation effort is similar to the one you heard 3 earlier, where there's been some off base contamination identified that's co-mingling with the Kelly plumes, and in an effort to stem the flow of contaminants from those off base sources, we're going to be installing a PRB, another permeable reactive barrier. The goal will be to treat the

contaminants down to the maximum contaminant levels so that when they go beyond the wall, they will no longer be co-mingling with other contaminants out there.

The PRB will be installed in two links, one approximately a thousand foot long and another one approximately 500 foot long. These will be installed to a depth of approximately 35 feet deep. We will be using a zero bound iron wall similar to the one you heard about previously. We'll have a different construction technique than the trenching technique. This will be where we will be injecting iron using an Hazmat control vertical hydraulic fraction, which I will describe that process to you momentarily.

The zero bound iron PRB's, basically, as John mentioned earlier, they'e a passive system for treating contaminated ground water in place. They're proven in both laboratory and field studies. It's an

A-biotic degredation process of the contaminants as opposed to like NC2 bioremediation.

some of the more important design elements are the contaminant concentrations and the ground water velocities, where we use those to calculate the residence times, how long all right contaminants remain in contact with iron, so that we can calculate the barrier thickness. And in this case, for the contaminant concentrations and the ground water flows that we have identified in the area where we'll be installing the plume, the wall will be approximately three inches thick, with an iron loading of about 45 pounds per square foot, which is slightly different than the two to three foot thick walls that are being installed using the previous method.

Next slide, please.

Some of the advantages to this injection process is there's no excavation and a minimum site disturbance. This is particularly important in the area where we're going to be installing it because we will be installing it adjacent to an active railroad, and so the trenching, the disruptive process associated with the trenching and potential hazard to the railroad led us to this other type of in placement technique. It's a bit

1 more costly but it's also a lot safer with regard to 2 construction around the railroad. 3 Complete treatment underground. Again, 4 this is a proven technology. It's also going to be very 5 little disruption to the community. Again, this is 6 going to be along the railroad in an area that there are 7 no homes adjacent to it, so it's pretty much going to be 8 out of sight, out of mind with respect to the construction, and it's also fairly rapid as far as 9 10 construction. We install a series of wells and inject the iron and then move on. 11 12 Next slide, please. 13 Currently our schedule is such that the 14 draft design is under review, under Air Force review. 15 We are currently working access agreements with UPRR to get the access to the sites. We're getting an injection 16 permit from the TCEQ. We're required to apply for and 17 18 receive an underground injection permit for this type of 19 process. 20 Construction is scheduled to begin in the 21 first quarter of 2004 and it should be completed by the 22 end of the summer. 23 Next slide. 24 Here is an illustration of where we are 25 here. Here's east Kelly. This is the UPRR. I have to

apologize for the graphics. We threw this together and it didn't come out quite as well as I thought, but the two sections, this section here is approximately a thousand foot long. This section here is approximately 500 foot long and this is right along the UPRR railroad.

There is some contaminant sources that have been identified back upgradient from these two walls and the idea is that we'll cut the contaminant sources off here and prevent further migration out into the off base neighborhoods.

Next slide.

Here's an illustration of how the technology works. Essentially what we'll do is we'll install a series of wells along the alignment.

Approximately 150 wells will be installed. These are two inch diameter wells. They have a special casing with a special slided screen at the bottom.

installing these series of wells approximately ten to fifteen feet apart, they will tie into the well heads and they will mix a slurry of iron filings that's almost like a dust sized particle, as well as a food grade gel, almost like a guar gel, and then they inject that iron into the ground. And this vertical Hazmat control process, they align these screens such that fracture,

1 when they pump the iron into the ground, it creates a 2 fracture and this fracture publicates from well to well 3 and then the iron is carried from well to well and it 4 fills the fracture void. 5 And then when we're done, we'll basically 6 plug these wells up and restore the ground surface to 7 its original condition and you'll basically never know 8 we were there. 9 As you can see, contaminants upgradient 10 will pass through the permeable reactive barrier, be 11 degraded from a very similar manner that John discussed 12 earlier and concentrations should be done to at or below 13 the maximum contaminant levels for the contaminants of 14 PCE and TCE, the perchlorethylene and trichlorethylene. 15 Next slide, please. 16 Here is just some quick slides showing 17 some of the construction equipment. As you can see, 18 some fork lifts, some specialized pumping and mixing 19 equipment. 20 Next slide. 21 You can see drilling rigs very similar to 22 the rigs we used for our investigations will be used to 23 install the wells. They will install the series of 24 wells. The rigs will leave. They will come in with the

For the new RAB members, Zone 2 and 3 is sort of the central eastern and southern part of the base. It's kind of the heart of what used to be the industrial complex on the base.

We're in the process of finalizing our response to TCQ and EPA comments on the Zone 3 recla facility investigation that's the RFI. That's projected to be done by the end of February. Once we have completed that report, we will also be submitted in March, the next step in the process, which is the corrective measures study, where we'll evaluate various alternatives that are appropriate for clean-up at various sites within those areas and make recommendations and propose alternatives for the cleanup of those sites, and that will be submitted as a draft to the state and EPA in the March time frame, and hopefully, you know. And of course, we'll have briefings at the TRS, RAB's and public meetings, all that, but if that's approved, then we'll start working on installing those remedies hopefully as soon as this year.

So we're working closely with the state and EPA on, you know, keeping the schedule and getting those reports to them so we can continue our progress

1 forward 2 In addition, we have numerous smaller 3 The kind of things you guys are hearing about units. 4 tonight are real, you know, huge projects, multi million 5 dollar projects. We also have many smaller projects 6 where we're closing smaller type of units, old wash 7 rags, oil water separators, storage vards, and we've been providing updates at the BCT to the state EPA on 8 9 our progress and investigation of those smaller units, 10 and those we just kind of give updates periodically as 11 we get data in on those types of sites. 12 So that's pretty much the status of BCT. 13 Any questions? 14 CHAIRMAN: Any questions? Since we're 19 kind of running out of space and there's a demand for 20 some office flex and office warehouse combination type 21 space, we're working on a project right now to develop 22 about a 15 acre site in some very mixed uses with small 23 offices for small type businesses, folks that need a 24 small amount of warehouse space, that type of thing. 25 That project probably will break ground for us end of

1 May, June probably time frame, depending on when we can 2 obtain our financing. 3 CHAIRMAN: Thank you, Mr. Martin. 4 Questions for Mr. Martin? Mr. Garcia? 5 MR. GARCIA: I just want to ask you, on 6 the main base, all the construction is going to go on on 7 the north end, have you considered building rail service 8 as well as truck service to serve the transportation 9 needs? 10 MR. MARTIN: Yes. As you're well aware, 11 we have the north/south thoroughfare that we're looking 12 at and working on, and part of that is reserving some 13 right-of-way for rail access, and Mr. Denitio asked, you 14 know, we've had several of our tenants that have won 15 some additional government contracts. 16 Standard Air and Lockheed Martin have 17 both obtained some new contracts and so we have some 18 additional work and they're adding somewhere in the 19 neighborhood, I think, between those two contracts, 20 about an additional hundred employees out at Kelly USA. 21 Thank you. 22 CHAIRMAN: Mr. Silvas? 23 MR.
