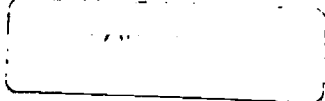

KELLY's RESTORATION ADVISORY BOARD TO MEET

KELLY AIR FORCE BASE, Texas – Kelly AFB's Restoration Advisory Board (RAB) will meet Tuesday, September 9, 1997. The meeting, held at Dwight Middle School on Southcross, is scheduled to start at 6:00 p.m. and end approximately at 9:00 p.m. The RAB will discuss issues related to the cleanup of the soil and groundwater currently underway at the base.

A variety of topics will be discussed during this meeting. A representative from the Environmental Protection Agency will report on the 1996 Basewide Remedial Assessment. The status of base cleanup actions will be the subject of a report presented by the Kelly Environmental Management staff. Time is set aside at every meeting for community comments and questions.

Kelly officials created the Restoration Advisory Board in 1994 to provide more community input into the environmental cleanup of Kelly AFB. Members include local residents, community activists, environmental regulators and local government representatives. The board is co-chaired by an Air Force representative— Mr. Edward Riojas, San Antonio Air Logistics Center Executive Director and Ms. Annalisa Pease, a community representative. All RAB meetings are open to the public.
