KELLY RESTORATION BOARD TO MEET MONDAY

KELLY AIR FORCE BASE, San Antonio -- The Kelly AFB Restoration Advisory Board will meet Monday, June 12 at 6 p.m. in the Knights of Columbus Hall at 5763 Ray Ellison Drive.

All Restoration Advisory Board meetings are open to the public.

Agenda topics include an upcoming public comment period and meeting on Kelly's proposed plans for the final cleanup of a shallow layer of water on the east, south and west sides of the base and adjoining off-base areas; a discussion of Kelly's environmental infrastructure; and an update on the Base Realignment and Closure process and it's potential impact on the environmental restoration program.

The Restoration Advisory Board ensures public input into the planning and implementation of environmental restoration activities at Kelly AFB. Board members promote community awareness and obtain constructive community review and comment

on environmental restoration actions in the base's overall cleanup program.

The Restoration Advisory Board is a part of Kelly's extensive Installation Restoration Program, which seeks out, investigates and, when necessary, cleans up past industrial waste storage and spill sites.

All Installation Restoration Program documents, including the proposed plans, are available to the public at the new San Antonio Central Library and at the Kelly AFB Library.
