AFRPA to Remove Catch and Release Signs at Heritage Lake

The Air Force, with the concurrence of the U.S. Environmental Protection Agency and the Illinois Environmental Protection Agency will remove the "catch and release" signs posted at Heritage Lake. In 2001, the AFRPA placed signs at Heritage lake advising the public to "catch and release" fish caught from the Lake due to an elevated mercury detection from one fish. The Remedial Investigation of Heritage Lake has been completed and this investigation concluded there is no evidence of a release of mercury or other contaminants of concern to this lake from Air Force activities. The USEPA and IEPA have concurred with this finding.

The "catch and release" signs at Heritage Lake will be removed in the spring of 2007. However, State officials have issued a statewide fish consumption advisory due to the concentration of mercury found in some types of fish caught in Illinois waterways. This advisory continues to apply to Heritage Lake. Based on the initial Remedial Investigation, the Air Force, with concurrence from the U.S. Environmental Protection Agency, and the Illinois Environmental Protection Agency, proposes no further action for these sites. The sites were sampled and analyzed for contaminants. Results of the analysis

Air Force Signs Finding of Suitability to Transfer

Another significant step in the cleanup progress has been reached at the former Chanute Air Force Base. The Air Force Real Property Agency gave notice of intent to sign a Finding of Suitability to Transfer of real property and any improvements on Parcels A1b-1, A1d and A2d-1, comprised of approximately 118 acres, at the former Chanute AFB to the Village of Rantoul.

The FOST is based on an extensive review of the environmental conditions of the property in consultation with federal and state environmental regulatory agencies.

The property will be transferred through a Federal Aviation Administration sponsored Public Benefit Transfer for aviation support.

An advertisement was placed in The Rantoul Press and The News Gazette December 27, 2006. informing the public of the Air Force's intent to sign the FOST.
