Dear Chanute Restoration Advisory Board Member or member of the public:

A Restoration Advisory Board (RAB) Meeting will be held on 16 May 2013 from noon to 1 p.m. The RAB Meeting serves as the periodic update for environmental progress and property transfer. The proposed agenda for the RAB Meeting is attached, along with the transcript from the 15 November 2012 Chanute RAB Meeting.

A Public Meeting for the former Chanute AFB will be held immediately following the RAB Meeting on 16 May 2013 from 1 to 2 p.m. The Public Meeting is being held to allow the public to provide input on a Proposed Plan for four landfill sites. The plan recommends the Final Remedies for the four landfills, which include the post-closure care requirements. The 30-day public comment period for the Proposed Plan will end on 17 June 2013 at 5 p.m. The Proposed Plan and Summary Sheet may be viewed at the Information Repository at the Rantoul Public Library, 2106 W. Flessner Avenue. Copies of the Proposed Plan and Summary Sheet will also be provided at the Public Meeting. Supporting documents can be accessed online at http://afrpaar.lackland.af.mil/ar/.

A Question and Answer Session will be held later the same day on 16 May 2013 starting at 6 p.m. The Question and Answer Session is being held for any interested parties that have questions about the Proposed Plan and the environmental cleanup at the former Chanute AFB and its progress.

Note that all three meetings will be held at the Rantoul Business Center, 601 South Century Boulevard, Rantoul, Illinois 61866. The RAB and Public Meetings will be held in the Main Conference Room. The Question and Answer Session will be held in Suite 1500.
