1 PROCEEDINGS 2 MR. SUELTENFUSS: Let me introduce 3 myself, I'm Tim Sueltenfuss. I just recently 4 learned how to say that last name so I don't 5 expect anybody here to be able to do it. 6 I work with Booz Allen Hamilton, and I 7 lead community relations support for a number of 8 Bases including Chanute. 9 LeAnn Herren is also on our team, and 10 she and I sit at the former Kelly Air Force Base 11 in San Antonio, Texas, right next to the Public 12 Affairs Officer who has responsibility for some 13 of the public affairs and community relations 14 work here at Chanute and all kinds of the central 15 AFRPA, Air Force Real Property Agency 16 Installations. 17 So, I'd like to just go ahead and jump 18 on in once we have everybody here and begin with 19 an agenda and head on into the discussions. 20 So our agenda today then is to start 21 off with a few introductions. We'll actually 22 just go around the table, allow everyone in the 23 room to introduce or reintroduce themselves. 24 We'll talk about some old business

1 which essentially encompasses just a couple sets 2 of Meeting Minutes from the last couple of RABs. 3 Then we'll hit the highlights of some 4 environmental cleanup updates, really focusing in 5 on the activities since February of 2004. 6 We'll talk about Landfill 2, the fuel 7 storage tanks update, some basewide sampling 8 that's been ongoing since March, and then the 9 community relations update as well. 10 We'll talk a bit about reuse progress, 11 and then we'll discuss the next meeting and some 12 logistical comments as well. 13 Does that sound good? Would anybody 14 like to suggest a different agenda item or a 15 different approach? 16 (No audible response.) 17 MR. SUELTENFUSS: So let's go ahead 18 then and start just with introductions. 19 I've kind of thrown my name out there. 20 I wonder if we can just start here and go around 21 the table and then we'll get everybody on the 22 outer side of the room. 23 MR. BRANDON: Scott Brandon, Village of 24 Rantoul.

1 MR. THOMPSON: I'm Owen Thompson with 2 US EPA Region V from up in Chicago. 3 MR. HILL: Chris Hill from the Illinois 4 Environmental Protection Agency out of 5 Springfield. 6 DR. HARRIS: I'm Bill Harris. I'm the 7 Environmental Coordinator for the Air Force here 8 at Chanute. 9 MR. FOTHERGILL: Caryl Fothergill, RAB 10 Member. 11 MS. WIRGES: Lorraine Wirges, RAB 12 Member. 13 MR. KOSKI: Gary Koski, Site Manager 14 for the Air Force here at Chanute. 15 MR. SUELTENFUSS: And then the guys in 16 the back row. 17 MS. SHIELDS: Diane Shields, Village of 18 Rantoul. 19 MR. HUNDSUCKER: Bill Hundsucker, citizen of Rantoul. 20 21 MR. WACKER: Dave Wacker. I work for Booze Allen Hamilton. 22 23 MR. SUELTENFUSS: And could you 24 introduce yourself as well.

1 THE REPORTER: My name is Lori Bernardy 2 and I am your court reporter. 3 MR. SUELTENFUSS: And is there anybody 4 that's not signed in? 5 (No audible response.) 6 MR. SUELTENFUSS: Let me also introduce 7 someone who is not here, Larisa Dawkins is the 8 Interim Public Affairs Officer. 9 As you might remember at the last RAB 10 meeting, Doug Karas came in who was the original 11 Public Affairs Officer and he announced that he 12 was taking over some responsibilities at Chanute. 13 Unfortunately for us, fortunately for 14 Doug, he is as of this very moment packing his 15 house and is about to move out to Washington, 16 D.C. and work at the Pentagon on some other 17 public affairs media relations. 18 So there will be somewhat of a change 19 there. Miss Dawkins regrets that she was not 20 able make it to this meeting but does anticipate 21 coming to RAB meetings at Chanute in the future. 22 Her information is available there and 23 I can give you additional contact information. 24 So now if we can go ahead and pass out

1 some of these RAB Minutes. 2 We're moving on to the Old Business 3 Section of our agenda and we have two sets of RAB 4 Meeting Minutes: one from the October 22, 2003 5 meeting and one from the February 25, 2004 6 meeting. 7 These have been provided in the past. 8 Is there anyone who has comments or changes to 9 these? 10 Miss Wirges, I know you had noted a 11 slight change. 12 MS. WIRGES: In paragraph three, second 13 paragraph of the February Minutes, you say that 14 occurred behind the former Enlisted Men's Club in 15 Operable Unit. 16 Were you talking about what we would 17 call the NCO Club where the Caddyshack is now or 18 the Enlisted Men's barracks that used to be there 19 in that area? 20 MR. FOTHERGILL: The new NCO Club, not 21 the Chandell Club. 22 MS. WIRGES: Over here? 23 MR. FOTHERGILL: Right. Uh-huh. 24 MS. WIRGES: But that wasn't Enlisted

1 Men's Club. 2 MR. FOTHERGILL: Yes, it was. It was 3 the Enlisted Club. 4 MR. SUELTENFUSS: Shall we take an 5 action to just identify the name? MS. WIRGES: I think the enlisted --6 7 MR. FOTHERGILL: It was called the Timbers Club. 8 MS. WIRGES: It was for the lower 9 10 ranking, it would be the Enlisted Club. 11 MR. FOTHERGILL: If you want to call it 12 the former Timbers, the former Timbers Club, 13 whereas the other one over here was called the 14 Chandelle. 15 MR. SUELTENFUSS: So if we made the 16 change to have that read the former Timbers Club, 17 would that satisfy things? 18 MS. WIRGES: That's fine, uh-huh. 19 MR. SUELTENFUSS: Any other changes 20 that need to be made to either of those two sets 21 of Minutes? 22 (No audible response.) 23 MR. SUELTENFUSS: Would you then like 24 to approve those Minutes?

1 Is there anybody opposed to approving 2 those minutes with that one alteration to change 3 the wording to the former Timbers Club? 4 MS. WIRGES: I move the Minutes be 5 approved as corrected. 6 MR. SUELTENFUSS: Okay. 7 MR. FOTHERGILL: I second. 8 MR. SUELTENFUSS: We have a motion and 9 a second. 10 Any discussion? 11 (No audible response.) 12 MR. SUELTENFUSS: And then we'll have a 13 vote. All those in support of that motion, say 14 "aye." 15 RAB MEMBERS: Aye. 16 $\ensuremath{\texttt{MR}}\xspace.$ SUELTENFUSS: The motion passes on 17 voice vote. 18 Any other discussion on that point or any other old business that should be taken into 19 20 account at this point? 21 MS. WIRGES: I hate to bring things up, 22 but last fall or during the summer months we had 23 asked for a tour for the RAB Members out into the 24 Landfill areas and the wildflower areas, and to

1 date that hasn't been accomplished. 2 We might just revise that this spring. 3 MR. SUELTENFUSS: Okay. All right. 4 If we don't address that before the 5 end, make sure and remind me. At the end we'll 6 try to capture action items. 7 MS. WIRGES: All right. 8 MR. SUELTENFUSS: I want to make sure 9 we capture that as well. 10 And with all of this, please feel free 11 to stop me and interject with any comments or 12 questions you might have. 13 So the structure of this briefing then is to first just give an overview and then delve 14 15 a little bit more deeply into each of these 16 aspects. 17 The Overview encompassing the 18 highlights since the last RAB meeting in 19 February: 20 In the Landfills category, the Air 21 Force installed erosion control material and 22 fencing at Landfill 2, closed five fuel storage 23 tanks, and collected over 1800 soil samples. 24 In the monitoring category, evaluated

1 over 50 groundwater screening locations.

And then some additional community relations have occurred. LeAnn and I happened to come up and assist the AFRPA staff in conducting 21 interviews for the update of the Community Relations Plan. That occurred the end of April, and we'll talk a little bit more in-depth about that.

9 Moving on into the Landfill 2 Update. 10 We have a picture there that shows some of the 11 activity that occurred. Erosion control 12 materials were installed and those were designed 13 of course to stabilize the soil on the steeper 14 slopes to allow the grass to grow, and then 15 eventually degrade naturally.

Also at Landfill 2 a security fence was installed and the purpose of that was of course to protect the integrity of the Landfill cap and prevent access to the site.

20 MR. BRANDON: What kind of grass are 21 they planning on planting?

Does that need to be mowed?
MR. GUTTMANN: Yes, it will be mowed
probably twice a year after it's established.

1	This year we don't have any mowing plans for it,
2	for that landfill cap in particular.
3	MR. BRANDON: Who will do that mowing?
4	MR. GUTTMANN: It will be a contractor.
5	MR. BRANDON: Okay.
6	MR. SUELTENFUSS: Any other questions
7	about Landfill 2?
8	(No audible response.)
9	MR. SUELTENFUSS: On the Fuel Storage
10	Tanks Update, out of 260 current or former fuel
11	storage tanks about 50 percent have been closed.
12	That's about 128, I believe is the specific
13	number there. Those tanks were removed and
14	tested. The soil in the vicinity of those tanks
15	was tested, and then the Air Force received
16	regulatory approval to close those tanks.
17	Of the remaining approximate 50 percent
18	of those 260 current or former fuel storage
19	tanks, the majority are in the final stages of
20	closure and almost complete which means that the
21	field work has been completed, and in general
22	there's some paper work, some additional
23	follow-up and those will be completed.
24	A smaller portion of that remaining 50

1 percent are still in the planning field work 2 phase. 3 Any questions there or additional 4 information needed? 5 (No audible response.) 6 MR. SUELTENFUSS: Okay, so let's talk 7 Basewide Sampling since March 2004. The sampling 8 is actually 85 to 90 percent complete, although I 9 should note that that percentage will probably 10 remain in place for a while as validation 11 continues. The latest round of sampling analysis 12 has been ongoing since June 2003. Of course we 13 have a picture of the former rifle range 14 sampling. 15 Also on the basewide sampling topic, 16 the Air Force has drilled over 200 soil borings 17 and collected over 1800 soil samples since March. 18 We have pictures of a couple of activities at the 19 golf course and near Building 927. 20 Any questions on Basewide Sampling at this point? Again, just stop me at any time if 21 22 you have anything. 23 MR. FOTHERGILL: Are they finding 24 anything significant during these samples or are

1 they just sending these samples off for lab 2 analysis? 3 MR. SUELTENFUSS: Darren, do you have 4 anything you want to add to that? 5 MR. GUTTMANN: As far as significance, 6 what we're doing is sampling to determine the 7 nature and extent of any contamination. 8 There's a whole list of contaminant 9 concerns that we have for different sites of the 10 Base. 11 We use field screening methods to 12 determine what interval to take the sampling, 13 soil sampling, but we don't have any real time 14 data until the data comes back from the 15 laboratory. 16 MR. FOTHERGILL: So what we're viewing 17 in the picture is just the diameter of the soil 18 sample? 19 MR. GUTTMANN: Yes. 20 MR. FOTHERGILL: How far down are we 21 going for this? 22 MR. GUTTMANN: For the initial round we 23 went down to 10 feet, and then if we have 24 something that comes back hot at that interval

1 and we don't have any groundwater data for that 2 sample location, then we're doing more vertical 3 delineation; we're going deeper. 4 MR. SUELTENFUSS: Any other questions 5 on that? 6 (No audible response.) 7 MR. SUELTENFUSS: The Air Force has 8 also installed over 20 monitoring wells and 9 evaluated about 50 groundwater screening 10 locations since March. 11 This is a good picture here of a well 12 installation in that former Fuels Training Area. 13 MR. FOTHERGILL: Didn't they do some 14 well monitoring off-base, south of here? 15 MR. GUTTMANN: Yes, we have residential 16 wells that we did south of here. We also have a 17 few background wells south of the Base. 18 MR. FOTHERGILL: Are we still 19 monitoring those? 20 DR. HARRIS: The residential, we have 21 completed the sampling rounds there. We have not 22 detected anything in the residential wells and 23 those reports actually go back through the State 24 Department of Public Health, and they issue back

1 to the residents a letter from them.

2 We do monitor also north of the Base, 3 some off-base sampling wells as just background 4 wells. So we do have some things off-base that 5 we continue to look at.

6 MS. WIRGES: The samplings that they're 7 doing south of the Base, does that include the 8 homes where we've been furnishing the water for 9 the last couple of years?

10 DR. HARRIS: Yes, those are the ones. 11 MS. WIRGES: And they're closed now? 12 DR. HARRIS: The sampling of the 13 residential wells is closed but we'll continue to 14 supply water to those residents that desire until 15 we have a Final Decision on that area down there. 16 One of the residents opted not to have 17 the bottled water anymore. That was their 18 choice, but we will provide them water. 19 MS. WIRGES: Thank you. 20 MR. SUELTENFUSS: At this point the Air 21 Force is reviewing sampling data. The purpose of 22 this is of course to determine if any 23 contamination exists, and if it does, what kind 24 of contamination it is and how much contamination

l there is.

24

2 We'll be validating the data as I 3 mentioned to make sure that that data is correct. 4 After validation one of a couple 5 options will be pursued: One is to close the 6 site if no further cleanup is needed. And then 7 the second option of course would be to conduct 8 additional cleanup at the site, and then close 9 that out. 10 If there are no other questions on that 11 piece, we can move to the Community Relations 12 Plan Update. 13 Anything we need to address that we 14 have not addressed on the previous section? 15 (No audible response.) 16 MR. SUELTENFUSS: Okay. Community 17 Relations Update. We are updating the Community 18 Relations Plan and we have conducted two rounds 19 of interviews to accomplish that, to provide 20 feedback and input for that Community Relations 21 Plan Update. 22 Eleven individuals were interviewed in 23 the spring of last year, and then as I mentioned

that last week in April, LeAnn and I and others

1 conducted 21 interviews in the area here. We 2 spoke with Village and community leaders, 3 business owners, and regulators, RAB Members, and of course members of the general public. 4 5 We are currently drafting the Community Relations Plan so we don't have that finalized 6 7 yet, but we can mention a couple high level 8 findings, preliminary findings. 9 The Community is most concerned about 10 conditions of the buildings on the Base. That 11 resounded as the number one concern, and also would like to see a timeline for Base cleanup and 12 13 transfer. 14 Also the best way to communicate with 15 the public is by newsletter, personal letters 16 and/or news articles in the Rantoul Press and 17 News Gazette. 18 One thing that was also mentioned in 19 those interviews that we conducted was that the 20 noon meeting time for the RAB was not all that 21 convenient for some folks and so that prevented 22 them from attending. 23 That was mentioned by a few people but

not the entire set of interviewees.

1 Any questions about that Community 2 Relations Plan Update? 3 (No audible response.) 4 MR. SUELTENFUSS: If we could talk a 5 little bit about Restoration Advisory Board 6 activities. 7 And, LeAnn, if you could pass out the 8 Operating Guidelines. 9 At the last RAB meeting in February, a 10 set of draft operating guidelines, also referred 11 to as a draft Charter, was distributed and I 12 believe was mailed out to those people who were 13 not able to attend the last meeting. 14 So at this point if the RAB Members 15 would like to you can vote to approve those? 16 Would anybody like to have discussion 17 about that or would you like to make a motion 18 related to either approving or rejecting those? 19 (No audible response.) 20 MR. SUELTENFUSS: It's my understanding 21 that there currently is no Charter or set of 22 Operating Guidelines for the RAB. These 23 Operating Guidelines were drafted by the Public 24 Affairs Officer based on operating guidelines

1 that are used at other Air Force Bases. 2 So again, what action would the RAB 3 like to take on this? 4 MS. WIRGES: How are you going to 5 establish terms for the RAB Members? 6 MR. SUELTENFUSS: Well, again, that as 7 all the elements of that are up for discussion. 8 At many installations, a two-year term is set for 9 community members and a one-year term for the 10 Co-Chair; however, that could be at your 11 discretion as well. 12 So an option would be just to go 13 through this and either approve it now, or if you 14 would like to take some more time to look at it 15 in a bit more detail, we could put that on the 16 agenda for the next RAB meeting. I see some 17 heads nodding in that direction. 18 Does that seem to be the consensus? 19 MR. HILL: Personally, I think it would 20 be a good idea to wait until the next meeting 21 when we might have some more RAB members here. 22 MR. FOTHERGILL: I kind of looked this 23 over. I got one in the mail, looked it over. 24 And this is pretty much what we're doing right

1 now.

We have like in Section 2, paragraph 2.6.2, it says: A representative from each of the United States Department of Defense, United States Environmental Protective Agency and the Illinois EPA, and we have those right here. And we've always had them right here at every meeting.

9 MR. SUELTENFUSS: I think the intent of 10 this was just to put on paper what you're already 11 doing.

MR. FOTHERGILL: It's a guide. You know, it's pretty much what we're doing right now, except it's just defining it on paper.

15 MR. SUELTENFUSS: When you did that 16 review of it, did you find anything that seems 17 out of place or that you would like to change? 18 MR. FOTHERGILL: Oh, in this paragraph 19 2.2.7, Removal of Community Members: Community 20 Board members in attendance may by a 2-thirds 21 majority vote remove a community member prior to 22 the expiration of his or her term if that person 23 is determined to be ineffective or detrimental to 24 the progress of the Board.

1 I fail to find anywhere prior to this a 2 definition of a board member's term. 3 Is it three years, is it five years, is 4 it indefinite or what? 5 DR. HARRIS: The paragraph right above 6 that are where the terms are. 7 MR. FOTHERGILL: Oh, okay. All right. 8 DR. HARRIS: If I could just speak, my 9 past experience having been at other locations 10 has been this is primarily used when people are 11 voted to be members of the Board and their 12 attendance, they basically are not attending the 13 meetings, and then you have a problem getting a 14 quorum together so that you can actually vote on 15 an action or something like that. 16 MR. FOTHERGILL: Well, I mean the word 17 "approximately" 2 years, that is not set in 18 stone, the actual term. Approximately could be 19 well four, or well, one. 20 MR. SUELTENFUSS: Again, we've had a 21 suggestion that we actually --22 MR. FOTHERGILL: I feel that, yes, the 23 term should be in there because paper is 24 expensive, you know. And if you're sending this

1 out to a person that doesn't attend the meeting, 2 you've got an expense that could be eliminated and that should be in there. I agree. 3 4 MS. WIRGES: I think it should cover 5 RAB Members as well as the community members, 6 because we have people who have not attended for 7 at least 2 years and then we have someone right 8 now who is undergoing chemo. 9 So, you know, that's a problem there. 10 So we have no avenue until we have this where 11 people can resign if they're unable to continue. 12 So this determines that portion. MR. SUELTENFUSS: We have a suggestion 13 14 to put this off until the next meeting. As I 15 mentioned before an option would be to vote on it 16 now. 17 Which direction would you like to go 18 with that? 19 MR. FOTHERGILL: Well, at least -- I 20 think I was the only member last meeting, and 21 this was provided then. And then I think I 22 received another copy in the mail. And I don't 23 think all the members are here. Where's --24 MS. WIRGES: (Inaudible).

1 MR. FOTHERGILL: And isn't there 2 another member? 3 MS. WIRGES: She's having chemo, so I 4 talked to her about not serving anymore and she said that would be fine. 5 6 Do you believe that 2 years is long 7 enough or can they be reappointed at that time? 8 MR. SUELTENFUSS: Yes, ma'am, they can 9 be reappointed at that time. 10 MR. FOTHERGILL: That's another 11 paragraph. 12 MS. WIRGES: Right. They must notify 13 the RAB of their intentions to seek reappointment 14 prior to roll call. 15 MR. FOTHERGILL: I think that was in 16 triple 2 paragraph. MS. WIRGES: The last paragraph. 17 18 MR. FOTHERGILL: -- can be reappointed. 19 You know, I've got a question. 20 MR. SUELTENFUSS: Okay. 21 MR. FOTHERGILL: If we have this, can 22 we add to as a supplement or vote on to eliminate 23 a paragraph? 24 MR. SUELTENFUSS: Under Section 2.6.2

1	Amendments, that allows a process by which to
2	amend the Operating Guidelines.
3	My sense is your feeling was to go
4	ahead and vote on this now; is that correct?
5	MR. FOTHERGILL: It doesn't matter to
6	me. How is a quorum defined? I think that was
7	the problem last time, I was the only one here.
8	MR. SUELTENFUSS: And that is an issue
9	now because there isn't a quorum definition right
LO	now; makes it difficult.
11	MR. THOMPSON: Yes, I think I don't
12	know what the point is in having 2 people adopt
13	it until we get some more attendance up. We
14	don't need a bunch of rules to resolve
15	disagreements and move forward. I've served on a
16	number of different BRAC sites and people serve
17	for life as long as they show up.
18	What's the difference between RAB
19	Member and a community member?
20	MR. SUELTENFUSS: A RAB Member is a
21	community member who's been appointed to the RAB.
22	MR. BRANDON: How do you become a
23	community member?
24	MR. SUELTENFUSS: Actually, it's a very

open definition, basically anybody who feels that 1 2 they have a stake, that they are stake-holding. 3 What direction would you like to go? 4 MS. WIRGES: Well, how many RAB Members 5 are supposed to be here? MR. SUELTENFUSS: In Section 2.1.1, 6 7 Ma'am -- oh, I'm sorry. It's based on your 8 current membership. 9 MS. WIRGES: There's supposed to be 10 five local RAB Members, and like I said there's 11 only 2 of us here. 12 MR. FOTHERGILL: Well, I think you just 13 said Cathy Marsh(sp) was going to withdraw. 14 MS. WIRGES: She'll withdraw. 15 MR. FOTHERGILL: So that leaves Louis 16 and Herman that are not here. 17 MS. WIRGES: (Nodded head up and down.) 18 MR. FOTHERGILL: And you're taking the 19 place of Gary Adams, right? MR. BRANDON: So what am I; am I a RAB 20 21 Member? 22 MR. FOTHERGILL: You can be. 23 MS. WIRGES: You would be RAB Co-Chair. 24 DR. HARRIS: The RAB Co-Chair is

1 actually voted on by the RAB Members as to who 2 they want to serve. 3 It can be anybody. Any one of your 4 members. 5 MR. KOSKI: Other than the regulators. 6 DR. HARRIS: So the RAB Membership will 7 decide who they want as their Co-Chair. It is 8 not an entity. 9 MR. BRANDON: So what is a minimum 10 number? It says the maximum number is 11 twenty-five, right? 12 DR. HARRIS: There is no minimum 13 unfortunately. 14 MR. BRANDON: Then how do you determine 15 a quorum? 16 MR. SUELTENFUSS: I believe it defines 17 quorum -- I can't identify the specific location, 18 but it's a proportion of the active members. 19 MS. WIRGES: Generally, if you go by 20 Robert's Rules, I think that it's 2-thirds of the 21 membership. And you have Robert's Rules of Order 22 listed here. It should be Robert's Rules of 23 Order Revised. 24

SUELTENFUSS: In the absence of a 6 Charter or Operating Guidelines, I'd say so 7 (inaudible). 8 MR. BRANDON: I'm really not prepared 9 to vote, I guess. 10 MR. SUELTENFUSS: The sense I'm getting 11 is that there are a number of members who would 12 like to put this off until the next RAB meeting. 13 Is anyone opposed to putting this off 14 to the next RAB meeting? 15 MS. WIRGES: Let's have a chance to 16 really study it and take it up at the next 17 meeting. 18 MR. BRANDON: What if we have 19 suggestions that we want to incorporate into 20 this, how should we go about that prior to the 21 next meeting? 22 MR. SUELTENFUSS: We will give you a 23 point of contact. You can either contact Lorisa 24 Dawkins or Dr. Harris if you want.

1 DR. HARRIS: We will get them to the 2 right people if you want to just provide them 3 back to us here locally. That's probably the 4 easiest for you guys. 5 MS. WIRGES: Right, give them to Diane? 6 DR. HARRIS: Yes. And then we'll 7 forward all those comments back to the actual 8 keeper of the electronic file. 9 MR. SUELTENFUSS: So the action then on 10 the Draft Operating Guidelines is for the RAB 11 Members to review it, provide comments back to 12 Dianna, and then we will revise those if 13 necessary and represent at the next RAB meeting. 14 MR. HILL: Is this Dianna Herbert, just 15 to clarify? 16 MS. WIRGES: Yes. 17 MR. HILL: Okay. 18 MR. If a 6 tank is like a backup tank for a generator, it 7 might still be in place. A lot of those have 8 been replaced by The Village with new tanks. 9 So some of them might still be there. 10 But like the underground storage tanks for 11 example, they should be removed and the checking 12 has been done in the soil to make sure there's 13 nothing there. And then now that we've got all 14 the data which should be written up as a report 15 to close it out. 16 DR. HARRIS: Just to let you know on the tanks also, we just this last week have 17 18 received the funding that should complete the 19 rest of this work. So we're fully funded with 20 what we believe it will take us to complete this 21 work. 22 The normal process would probably be 23 during the next physical year then or a year from

now, we would hope we would be completed. Part

1 of it is just to go through regulatory review and 2 once they get the regulatory review, there are 3 times that Illinois needs legal review which takes quite a long time sometimes at the Agency 4 5 to get into their legal office and back out of 6 there. 7 So we have recently received funding so it gives us funding at least to complete this 8 9 program. 10 MS. WIRGES: The whole thing? 11 DR. HARRIS: The storage tanks. We 12 have received additional funding also, so we are 13 fully funded for this year. So funding wise, we 14 are doing good. 15 MR. THOMPSON: As far as construction 16 being complete on tanks that you were expecting that to be removed, you know, 85 percent is a 17 18 pretty good number. 19 MR. SUELTENFUSS: Any other questions? 20 DR. HARRIS: We're hoping we won't find 21 anymore underground tanks. The problem is 22 because it's from old records and geophysics, all 23 sorts of things, trenching. 24 Sometimes when you're trenching for

1 something else, you'll find one - it's a 1917 2 installation - and sometimes you find things that 3 weren't ever on drawings, period. 4 MR. THOMPSON: In Fort Sheridan they're 5 still finding one or 2 a year. 6 MR. BRANDON: What are these tanks for? 7 DR. HARRIS: Oh, everything from 8 heating oil tanks to gasoline tanks for different 9 things. A lot of heating oil tanks up in this 10 part of the country, or associated with a 11 building, and the building has long since been 12 gone. 13 And the previous practice, you know, 14 back in the late '30s and early '40s was just 15 leave it. You take the building down and you 16 leave everything else. 17 MR. BRANDON: Including what's in it? 18 DR. HARRIS: Normally, it's -- once in 19 a while you'll find one with something in it. I 20 wouldn't say that you wouldn't. But the ones 21 I've been associated with, typically they're 22 filled with sand. They're inerted. 23 MR. THOMPSON: The ones that leaked 24 really bad didn't have any fuel in them.

1 DR. HARRIS: Right, it's empty for a 2 reason. 3 MR. BRANDON: Okay. I was just 4 stalling for Reed. 5 MR. SUELTENFUSS: Any other questions? 6 MS. WIRGES: Does the Co-Chairman sit 7 in on your meetings that you have when you're in? 8 Aren't you in for a couple of days, 9 meetings, you know, with Dr. Harris and other 10 people and the Co-Chairman sits in on that also? 11 MR. SUELTENFUSS: I believe that has 12 not been the standard practice. 13 DR. HARRIS: Typically, they do not sit 14 in on those meetings, and part of it is they're 15 fairly technical and long and drawn out. 16 I would have to ask how that goes, but 17 I'm not sure, they're considered executive only 18 meetings. And the idea is we have those meetings 19 and the outcome of those meetings should be 20 briefed back to the Restoration Advisory Board. 21 So that information is provided back in 22 a kind of a condensed version so that you don't 23 have to look at all the grueling numbers and 24 slides.

1 MR. HILL: You don't want to sit 2 through those meetings. 3 DR. HARRIS: There shouldn't be 4 anything that occurs in those meetings that is 5 not being passed on to you. 6 MR. HILL: Aren't the meeting Minutes 7 public record? 8 DR. HARRIS: Yes. <u>.</u> 9 MR. HILL: We have meeting Minutes 10 and --11 MR.
