AIR FORCE ENVIRONMENTAL ACTIVITIES AT MCCLELLAN

Protective cap clears way for public safety training

The cleanup and redevelopment of the former McClellan Air Force Base realized another major achievement recently: completion of a protective cap while also creating a safe, cost-effective place for public safety training.

Decades ago, the Air Force used this area on the west side of the base for landfills and a fire training area. It was later discovered that these activities led to contamination of the soil and groundwater. Groundwater cleanup has been ongoing since the 1980s.

This year, with approval from State and Federal regulatory agencies, the Air Force completed installation of a protective engineered cap over the area. This paves the way for the site to be fully utilized by the Sacramento Fire Department.

Thanks to this cost-effective and safe cleanup remedy, the Sacramento Fire Department is able to expand its training activities currently restricted to an area around the five-story brick structure previously used by the Air Force for fire training activities.

"We're excited about being able to use the area for training," said Sacramento Fire Department Capt. David Kevin. "McClellan is a really good fit for us. Its location is a cost savings for the city, so it is very beneficial. And having some space for future growth is also advantageous."

The Sacramento Fire Department currently operates an Urban Search and Rescue Team (CA-TF7) and a fire training academy for public safety agencies in the region. Rope rescue, firefighting, search and rescue training, and wildland and other fire training exercises are conducted on and around the brick tower.

"Many of the amenities at former bases like McClellan lend themselves very well to reuse by public safety entities," said Steve Mayer, AFCEC environmental coordinator at McClellan. "It's a good news story to see places like the fire training area continue to be put to good use by local organizations."

The combined cap over these sites is part of the larger Focused Strategic Sites project at McClellan. The Air Force, US Environmental Protection Agency and State of California agreed on the final cleanup decision for these sites in 2012. The cap will be maintained and monitored by the Air Force to ensure its protectiveness into the future.




