2018 Bovine Tuberculosis Zoning Order Public Notice

The Michigan Department of Agriculture and Rural Development is proposing revisions to Michigan's bovine tuberculosis zoning order, most recently amended on June 7, 2016. The following is a summary of the proposed changes to the zoning order:

- Would establish an Enhanced Wildlife Biosecurity (EWB) Area within the Modified Accredited Zone (Alcona, Alpena, Montmorency and Oscoda counties).
- To move cattle, other than directly to slaughter, cattle producers in the EWB Area would be required to complete an Enhanced Wildlife Biosecurity Assessment and implement assessment recommendations by January 1, 2020. In addition, producers would provide the U.S. Department of Agriculture Wildlife Services access and permission through a Landowner Agreement Form to remove deer in and around cattle facilities. This agreement must be signed by July 15, 2018.
- All cattle herds, other than freezer beef herds, in Presque Isle County would undergo whole herd TB surveillance testing
