# Notice of Availability Proposed Plan and Public Meeting Van Etten Lake at Ken Ratliff Memorial Park Interim Remedial Action Former Wurtsmith AFB, Michigan

The lead agency, the United States Air Force (Air Force) will hold a public meeting to discuss the proposed plan for the interim remedial action (IRA) addressing perfluorooctane sulfonate (PFOS) and perfluorooctanoic acid (PFOA) that is migrating via groundwater from aqueous film-forming foam (AFFF) Area 1 (Base Operation Apron) and AFFF Area 15 (Site SS-71) into Van Etten Lake at Ken Ratliff Memorial Park at the former Wurtsmith Air Force Base, Oscoda, Michigan. The proposed plan identifies the Preferred Alternative and the Air Force invites the public to comment on the proposed plan.

The Air Force evaluated the following IRA alternatives for reducing the groundwater plume migration into Van Etten Lake at Ken Ratliff Memorial Park:

- Hydraulic control using pump and treat by granular activated carbon (GAC)
- Hydraulic control using pump and treat by ion exchange resin
- No Action

Based on available information, the preferred IRA alternative proposed is hydraulic control using pump and treat by GAC. Although this is the IRA Preferred Alternative at the present time, the Air Force welcomes the public's comments on all of the alternatives listed above. The comment period ends on September 3, 2021. The Air Force will choose the final IRA alternative after the comment period ends and may select any of the alternatives after considering public comments.
