to overflowing, this well attended Perchville activity was bursting at the seams. The excitement of the crowd added to the amped up adrenaline of its racers, all focusing intently on the flag man who began each race. On each side of the field, two identical courses of blue and white barrels were symmetrically staged

against a back-drop of a clear blue sky that barely held a breeze.

In the running for favorite event, even if one does not participate, is the Polar Plunge. It is so popular that two events are scheduled on Saturday afternoon to accommodate everyone. Malone shared that there were about 120 participants with most of them coming to the earlier one, including the king and queen of this year's Perchville. Just to the left of the Tawas Bay Beach Resort on the ice of the bay, the Coast Guard set up a large hole close to shore so that it would not be too deep and had positioned a ladder in the water for exiting safely.

While younger children played on the ice near the shore, and a crowd gathered to watch, those who desired to try out this cold weather tradition braved the slippery walk from shore to the waiting plunge point. One at a time, these winter warriors jumped insome in bathing suits, some in costume, some in dive suits and some fully dressed. There were many ways to enter the frigid water such as jumping feet first, cannonball, belly flop, back flop, twists, giant leaps and some that looked like possible changes of the mind that

occurred too late to turn back ending in very interesting positions. Anyone who did not get a chance this year to participate in this icy activity will surely have another chance next year and a whole year to work up their courage.

Funding was awarded in nine of the state's 10 prosperity regions, representing at least one grant for every region which applied.

Of the awardees, 10 are Brownfield sites and will be receiving 49% of the funding. The remaining recipients, are Greenfield sites.

The MEDC says that creating a robust inventory of investment-ready sites of all sizes will provide Michigan with increased opportunities for business attraction and expansion projects.

The awards total \$87,546,962. The remainder of the full \$100 million SSRP allocation will support applications requiring more time/ evaluation, additional needs that may come up later in the year and also allow funds to be available to support sites that enter the site readiness certification program which is scheduled to launch this fiscal year.

Due to high demand on the limited funds, the MEDC has submitted a list of applications which self-identified as Brownfields to the Michigan Department of Environment, Great Lakes and Energy, to review for potential assistance.

'With a resetting of the industrial landscape currently underway in the U.S., the communities and economic development agencies that are proactively preparing industrial sites and training the workforce of tomorrow will be the winners in this race – the outcome of which will determine which states and regions will lead in economic and equitable prosperity over the next 20-30 years," says Detroit Regional Partnership President/CEO Maureen Krauss.

"The approval by the MSF Board in the Strategic Site Readiness Program is paramount to Michigan's success, and the Detroit Regional Partnership is aligned with the MEDC through our Verified Industrial Properties Program (VIP by DRP) to support our region's commitment to ready

more sites, to help Michigan win its share of the critical job creation

projects," Krauss adds. Established in December 2021, SSRP provides financial incentives to eligible applicants to conduct eligible activities on, or related to, strategic and large-scale sites in Michigan to attract and promote investment in the state.

The SSRP was among several initiatives in the economic development bills which were signed into law by Whitmer. Public Act 194 of 2022 authorized additional SSRP funding and directed it at specific SSRP categories, including a \$100 million allocation for strategic sites where an end-user is unknown. Legislative approval of the transfer of those dollars from the Strategic Outreach and Attraction Reserve fund to the Michigan Strategic Fund was made in June 2023.

'On behalf of the MEDC, it is exciting to be able to support local communities in their business development efforts as they bring forth sites of all sizes to prepare for economic development opportunities in their region," stated Terri Fitzpatrick, MEDC executive vice president and chief real estate and global attraction officer.

According to Fitzpatrick, because of Whitmer and the Michigan legislature's continued efforts to attract business developments and grow the state's economy, these site readiness projects will create meaningful impact throughout Michigan. "While this is a good start, the demand remains substantial and will require continued funding for years to come.'

River Road are on the township's plan for replacement in 2024.

The accompanying boil water alert covered a large section of Oscoda including River Road and areas north including the entire former Wurtsmith Air Force Base.

Oscoda Area Schools were closed on Tuesday Jan. 30 due to the lack of water. With the boil water alert being in effect for 48 hours, the schools sent out a notice to parents asking they send students to school with a water bottle.

Superintendent Scott Moore sent out a second email to parents on Wednesday letting them know that Cal Thomas, who works for the AuSable Township Department of Public Works, would be testing the water and that the school was bringing in bottled water for students.

On Thursday morning the Robert J. Parks Library, located on the former base, had a sign on the drinking fountain to not drink

the water.

As of late Thursday afternoon the boil water alert was no longer posted on the township's website.

It is unclear why some residents received alerts when others didn't.

This publication reached out to Trustee Jeremy Spencer, who is the township's representative on the 911 board, to see why some residents received alerts, some received multiple alerts and others weren't notified at all. As of the publication deadline, no response had been received.

Individuals who notice a problem with the water system during township office hours, Mondays through Fridays, from 9 a.m. to 4 p.m., should contact the Oscoda Township water department at 989-739-3211 ext. 260.

If a water or sewer problem is noticed outside of those hours, contact the emergency number at 989-362-1430.
